# What did the NAM Future of Nursing report say, and why is it important?

The Future of Nursing report identifies the nursing profession as a central component in improving the healthcare system, and provides evidence-based recommendations on training, education, professional development, leadership, and workforce policy.

These recommendations aim to create a patient-centered healthcare system that relies on research and the transformative power of nursing to advance healthcare across the country.

### **Key Recommendations**

- Nurses should practice to the full extent of their education and training.
- Nurses should achieve higher levels of education and training through an improved education system that promotes seamless academic progression.
- Nurses should be full partners, with physicians and other health care professionals, in redesigning health care in the United States.
- Effective workplace planning and policy-making require better data collection and improved information infrastructure.

The report calls on the nation's leaders and stakeholders to act on recommendations in these four key areas. Nursing organizations have long been committed to strengthening the profession, and their past work provides much of the foundation for advancing the NAM's recommendations.
